

Cost Management in Shipbuilding and Super Yacht Building

Planning, Analysing and Controlling Product Costs

4th December 2014 in Genova from 11:00 to 16:00

Topic

A ship's cost is defined before production starts. Therefore, cost planning and control start with design and engineering. Several methods like similarity calculation or parametric analysis can be used for cost estimations in new projects. Risk analyses allow to assess the reliability of the estimates. By contrasting the costs of ship capabilities with their values for the customer, approaches for cost cutting activities can be found. Finally, costs of the in-service phase can be optimised by Life Cycle Costing.

Event

The event "Cost Management in Shipbuilding and Super Yacht Building" will offer the opportunity to learn about methods supporting cost planning, cost analysing and cost reduction in naval engineering. A focus is on the software "CostFact". This system supports cost planning from early design and engineering stages on, cost analysis of already concluded projects and life cycle costing. The event will also be useful for project managers. Those who are working on engineering design will also benefit from attending.

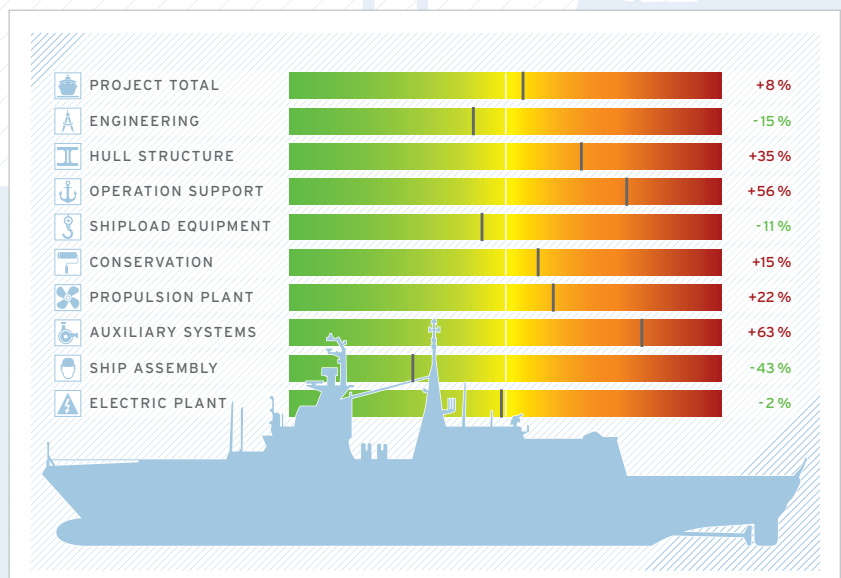
Date and Registration


